# 富蘭克林坦伯頓中小型公司成長基金 財務報告附註

#### 1. 組織結構與重要會計政策

富蘭克林坦伯頓中小型公司成長基金(以下稱本基金)是依據美國 1940 年投資公司法案(簡稱為 1940 法案)註冊成立的開放式投資公司,並且採行美國一般公認會計原則(U.S. GAAP)之專業會計和報導指南。本基金提供四種股份類別:A股、C股、R6 股及 Advisor 股。C 股在持有 8 年後每月將自動轉為 A 股。各股份類別的首次銷售手續費、或有遞延銷售手續費、對單一股份具影響之事件的投票權、及轉換權益不同約定之分銷費用及股務代理機構費用皆有所不同。

本基金重要會計政策摘要如下:

#### a. 財務工具評價

本基金為每日以公平價值(fair value)評價投資的財務工具。公平價值是市場參與者於秩序交易中,賣出資產或轉移負債於衡量日所被買賣參與者接受的價格。本基金在每個營業日東部時間下午 4 點或紐約證券交易所 (NYSE) 正常排定收盤時計算每股資產淨值 (NAV),以較早者為準。在本基金董事會所核准的政策及程序下,本基金的行政經理公司負責監控及評價的範圍包括:主導具有交叉功能之**評價委員會** (the Valuation Committee (VC))。本基金得以利用獨立定價服務、來自證券和財務工具的交易商所提供的報價及其他市場資訊來決定公平價值。

在證券交易所或那斯達克交易系統掛牌之股票是分別以最後公告售價或當日官方收盤價格計價。外國證券是以證券主要交易之外國證券交易所或是東部時間下午四點收盤價估值。其價格將以國外證券依當日東部時間下午四點的收盤匯率被轉換成美元後的價值而定。店頭市場交易證券其估值則不超過最近一次的買賣報價範圍。同時在多個市場或多個交易所進行交易的證券,其估值則以最具廣度和代表性之市場的報價為準。某些股權證券是以類似證券的基本特徵或關係為評價基礎。

債權證券通常是在店頭市場而不在證券交易所進行交易。本基金的定價服務是使用多種評價技術來決定其公平價值。於交易活絡的市場,定價服務可能利用市場基礎法(market-based approach),即使用證券交易公司的報價來決定公平價值。於交易不活絡或有所限制的市場,定價服務亦使用財產評價模型(proprietary valuation model),其考量了市場特性(例如:基準收益率曲線、信用價差、估計違約率、預期市場利率變動性、票券利率、本金付款期待時間、擔保品及其他獨特的證券特性)來評估相關的現金流量,並再用折現法計算公平價值。

投資於開放式共同基金則以結算後的淨資產價值評價。

當財務工具缺乏可以信賴或是無法獲得市場價格時,本基金採用特定程序來決定其公平價值。在這些程序下,本基金主要使用市場基礎法(market-based approach),即使用相關或可比較之資產或負債、近期交易、市場乘數、帳面價值及其他投資主要資訊來決定投資之公平價值。收益基礎衡量法(income-based valuation approach)也可用於投資之預期未來現金流量折價以計算公平價值。由於處分投資的限制的本質或是存續期間,可能也使用折價來計算。由於此類投資評價固有的不確定性,其公平價值與交易市場的價格可能會有顯著的差異。

於外國證券交易所及店頭交易市場掛牌證券的交易,可能早於東部時間下午四點時間。此外,某些外國市場的交易並不會發生在每一個基金的營業日內。有時候,在外國證券交易完畢與東部時間下午四點之間的時間裡發生的事件可能對本基金所持有之投資組合證券價值的可信度造成影響。因此,由外國市場收盤後所決定之基金組合證券價格與東部時間下午四點最近

#### a.財務工具評價(承續前文)

的價格間,可能會產生差異。為了最小化這些潛在的差異,獨立定價服務可於下午 4 點將本基金的投資組合證券的價值調整為最新的公平價值指標。截至 2022 年 8 月 31 日,部分證券已使用公平價值程序來定價,在這種情況下,這些證券被分類為公平價值衡量層級中的等級 2。(稱為"市場公平價值")更多說明,請參閱"公平價值衡量"附註。

當申報期間的最後一日為非營業日時,某些外國市場可能在未計算基金資產淨值的那些日子開市,此可能造成基金投資組合證券的價值在申報期間的最後營業日及最後日曆日間所有差異。任何因外國市場開市所造成之顯著證券價值變動將被基金為反映財務申報目的而進行調整和反映。

#### b. 外幣轉換

投資組合中以外幣結算的證券以及其他資產與負債,是在估值日以這類外幣對美元的匯率轉換成美元來定價。本基金可能簽訂外匯契約協助以外幣計價的交易。以外幣結算之證券的申購與銷售,收益與費用項目是以在交易日生效的匯率轉換成美元來定價。以外幣計價之投資組合證券、資產及負債包含這些外幣相對於美元價值下跌的風險。有時候,事件的發生可能影響外幣對美元匯率的可獲得性或可信度。若有此類事件發生,將以本基金董事會所建立並核准之程序來確定該匯率的公平價值。

本基金並不會單獨報告由於持有證券的市價變動而引起的外幣匯率變動的結果。這類的變動已包含在經營業績表中的淨實現與未實現投資利得或損失中。

已實現的匯兌利得或損失來自於外幣銷售、在證券的交易日與交割日之間所實現的貨幣利得或損失及股利、利息、外國預扣稅的紀錄金額與其實際交付的等值美元金額之間的差異。淨未實現匯兌利得或損失來自於在報告期末除所持有的投資證券之外,以外幣結算之資產與負債的外幣匯率變動。

#### C. 證券借貸

本基金參與一項代理機構基礎之證券借貸計劃以賺取額外的收益。本基金對借出證券收取現金擔保品其相當於所借出證券之公平價值至少 102%的金額和/或美國政府和機構證券的擔保品。在此借貸的存續期間內擔保品的金額不低於該借出證券公平價值(在基金各營業日結束時評定)的 100%,任何因證券價值變動而須追加的擔保品必須於次一營業日交付給本基金。擔保品係被存放在與其他基金共同的聯名現金帳戶,且習慣投資在由富蘭克林顧問公司(本基金之關係企業)所管理的貨幣市場基金裡。在 2022 年 8 月 31 日,本基金收到\$69,238,541 美元的美國政府機構證券做為擔保品。這些證券在基金託管人的獨立賬戶中作為抵押品持有。基金不能再質押或轉售這些作為抵押品的證券。因此,非現金抵押品不包括在資產負債表中。本基金得收取來自現金擔保品的投資收益,以及從借貸者收取出借費用與回扣。來自證券借貸的收益,扣除支付予證券借貸機構以及/或是第三方供應商的費用,已分別地註記在經營業績表中。本基金承擔有關擔保品投資與證券借出的市場風險,以及代理機構違反其對本基金義務的風險。如果借貸者違反其應返還借出證券的義務,本基金有權利運用所收取的擔保品於公開市場再買回這些證券。證券借貸機構已同意賠償本基金由第三方借入者產生的違約風險。

#### d. 所得稅及遞延稅

按照基金政策,本基金必須符合美國稅務法對於投資公司的規定,對股東分配幾乎所有的應稅收益與淨實現利益以免於繳納聯邦所得稅及特許權稅,因此無需預提美國聯邦所得稅。

- d. 所得稅及遞延稅(承續前文)

本基金在外國管轄區域的投資所收取的收益、證券售出的資本利得以及一些外匯交易可能須繳納外國稅捐。如有外國稅捐,其金額將依據本基金所投資之外國市場實施的稅務法規與稅率申報。如外國對淨實現利得加以課稅,本基金將記錄預估的遞延稅賦義務,其金額相當於當證券在評價日交易須支付的稅額。

由於遍及歐盟一些國家的幾個訴訟案件結果,本基金已經為以前在這些國家所賺取股利的代扣稅款申報追加的回收稅款(歐盟回收)。已認可收益,若有的話,這些歐盟回收金額是以其他收益反映於經營業績表中,而任何相關應收款項,若有的話,是以歐盟稅款回收反映於資產負債表中。而與以上相關之費用也將反映在經營業績表的其他費用上。當這些訴訟的最終裁決、取得這些回收稅款的可能性以及付款的可能時間安排尚存有不確定性時,則無金額得以被反映於財務報表中。就美國所得稅目的,本基金所收取的歐盟回收稅款,若有的話,將減少外國稅捐金額而使本基金股東得在個人所得稅申報單中作為減稅或抵免。

只有當稅務機關基於稅項的技術優勢進行依據美國一般公認會計原則(U.S.GAAP)審查時認為該不明確稅項維持的可能性低於50%的情況下,本基金才會承認不明確稅項的賦稅利益。於截至2022年8月31日止及所有開放稅賦年度,本基金認為沒有因被要求於納稅申報表所揭有關不明確稅項之納稅申報(或預計在未來進行納稅申報)之未承認賦稅利益而產生的負債。開放稅賦年度為基於稅賦管轄權之法定時效限制下仍須接受審查的年度。

#### e. 證券交易、投資收益、費用及配息

證券交易是在交易日作入帳。證券交易之已實現利得或損失則決定於特定基礎。利息收入與預估費用則每日計提。利息收入包括債權的折價與溢價攤銷。股利收入是在除息日入帳,除了某些來自外國證券的股利是在本基金接獲除息日通知才立即認定。對股東的配息是在除息日入帳並且依據所得稅法(稅基)確定。以稅基所決定的可分配盈餘可能不同於依照一般美國公認會計準則所紀錄的盈餘。這些差異可能是永久或是暫時的。永久性差異將產生在資本帳戶被重新分類以反映其稅賦特性。這些重新分類對淨資產或是經營業績並不會造成影響。暫時性差異則不用重新分類,因為差異在後續期間將會迴轉。

已實現與未實現利得與損失以及淨投資收益(股份等級特定費用除外),是依照個別股份等級的淨資產之相對比重而每日分配到個別股份等級。股份等級的費用差異可能導致各股份等級每股配息款項的差異。

#### f. 會計估計

管理階層依照美國一般公認的會計準則編制財務報表時需要做出會計估計與假設。這些會計估計與假設會影響於財務報表日的資產與負債金額以及在財務報表期間的收入與費用金額。實際結果可能與估計值不同。

#### q. 保證及賠償

在本基金的組織文件規定下,本基金同意免除其主管與董事對於某些超越其職責範圍而發生的負債的責任。此外,在正常業務狀況下,本基金代表本基金與服務提供機構簽訂契約也包含責任免除條款。本基金在這些免責條款下的最大風險是未知的,因為涉及未來可能對本基金發生的被訴訟索賠。目前,本基金預期損失的風險是很小的。

#### a. 管理費用

本基金按基金的平均每日淨資產價值所適用之年率標準每日計算,每月支付 TIC 投資管理費用,年率標準詳如下表:

依據附屬經理公司合約,FTIC (其為 TIC 的關係企業)對本基金提供附屬顧問服務,並從 TIC 收取基於本基金平均每日淨資產的投資管理費用,並不是本基金額外的費用。

#### b. 行政費用

依據與 TIC 的契約,FT Services 對本基金提供行政管理服務。TIC 按本基金的每日平均淨資產支付行政管理服務費用,其並不是本基金額外的費用。

#### C. 配銷費用

除了 R6 股及 Advisor 股以外,本基金董事會遵循美國 1940 年投資公司法案的規則 12b-1,對於各股皆採用配銷計劃。在本基金 A 股的償還配銷計劃下,本基金將向 Distributors 償付不超過最高年度計劃費率的配銷費用,用以彌補其服務、銷售與配銷本基金股份所帶來的費用。在 A 股的償還配銷計劃下,當期計劃年度的費用超出最高償還額度的部分不會在後續期間得到償還。此外,在本基金 C 股的補償配銷計劃下,本基金將向 Distributors 支付不超過最高年度計劃費率的配銷費用,用以彌補其服務、銷售與配銷本基金股份所招致的費用。為監控最高年度計劃費率之遵循情形,該計劃年度為 2 月 1 日至 1 月 31 日的整個期間。

按本基金的平均每日淨資產的特定比例,各股的最高年度計劃費率列示如下:

#### d. 銷售手續費/承銷合約

前收型銷售手續費以及或有遞延銷售手續費(CDSC)不是本基金的費用。這些手續費在投資之前就從基金股份銷售款項中扣除,或是在贖回收益匯出之前被扣除(若適用)。 承銷商(Distributors)已告知本基金下列有關本期間基金股份銷售與贖回的交易佣金:

扣除支付給非關係企業的交易商/經紀商佣金後的銷售手續費 \$46,300 保留的或有遞延銷售手續費 \$4,350

#### e. 股務代理機構費用

每個基金股份為 Investor Services 對股東服務範圍的績效支付股務代理機構費用義務。費用基礎為年化資產費用的 0.02%加上交易基礎費用。此外,除了 R6 股,每個股份償付 Investor Services 的墊付款項以及支付予第三方的股東服務費用。這些費用將以各個股份淨資產的相對比例為基礎每日配置於各該股份。R6 股僅對該股支付 Investor Services 股務代理機構費用。

在截至 2022 年 8 月 31 日止之年度,本基金支付股務代理機構的費用為\$ 1,562,320 美元,其中\$ 489,452 美元是用以支付 Investor Services。

#### f. 投資於關係企業管理投資公司

本基金投資於一家或數家關係企業管理投資公司。根據 1940 年法案的定義,當基金直接或間接擁有附屬基金 25% 或更多已發行股份或有權對管理行使控制權時,該投資被視為基金的 "控制關係企業"。本基金的投資目的不是對管理或政策施加控制影響。本基金可減免投資於關係企業管理投資公司的資產所對應的管理費用已標示於經營業績表中,但金額不超過每一個關係企業直接或間接所支付的管理費用和行政費用。截至 2022 年 8 月 31 日,本基金持有投資於關係企業管理投資公司如下:

收益以及/或是資本利得在帳面基礎與稅賦基礎上有所不同,主要是因為對歐盟稅款回收、被動外國投資公司股份、轉嫁實體收益、企業活動以及沖銷性交易的處理不同而影響分配的特性所致。

本基金採用稅務會計慣例會將部分來自贖回股本收益款項視為來自淨投資收益的分配。

#### 5. 投資交易

#### 10. 信用工具

本基金與富蘭克林坦伯頓基金集團所管理的其他美國註冊以及外國投資基金(全體地,以下稱「全體借用人」)共同簽定一項於2022年2月3日到期之貸款總額為26.75億美元的優先無擔保聯合全球信用貸款(以下稱「全球信用工具」)。全球信用工具其為一項資金來源,提供予全體借用人以因應暫時與緊急之資金需求,包括有能力去應付未來無預期或不尋常的大量贖回需求。

During the 12 months ended August 31, 2022, global equities benefited earlier in the period from ongoing COVID-19 vaccination programs and some easing of restrictions. However, the combination of resilient consumer demand and persistent supply-chain disruptions contributed to higher inflation in many countries, which led many of the world's central banks to adopt less accommodative monetary policies in 2022, hindering stocks. New lockdowns by China to limit the spread of COVID-19 variants also pressured emerging market stocks, especially in Asia, and Russia's invasion of Ukraine increased investor uncertainty given the resulting disruption of global trade and commodity markets. In this environment, small-capitalization stocks in global developed and emerging markets, as measured by the MSCI All Country World Index Small Cap Index-NR (net of tax withholding when dividends are paid), posted a -18.73% total return for the period.1

We are committed to our long-term perspective and disciplined investment approach as we conduct a rigorous, fundamental analysis of securities with a regular emphasis on investment risk management.

Historically, patient investors have achieved rewarding results by evaluating their goals, diversifying their assets globally and maintaining a disciplined investment program, all hallmarks of the Templeton investment philosophy. This annual report for Templeton Global Smaller Companies Fund covers the fiscal year ended August 31, 2022.

#### Your Fund's Goal and Main Investments

The Fund seeks to achieve long-term capital growth. Under normal market conditions, the Fund invests at least 80% of its net assets in securities of smaller companies located anywhere in the world. For this Fund, smaller companies are companies with market capitalizations not exceeding the lesser of the highest float-adjusted market capitalization in the Fund's benchmark, the MSCI All Country World Index (ACWI) Small Cap Index-NR, or \$10 billion, at the time of purchase. The Fund may invest a significant amount of its assets in the securities of companies located in emerging markets, will invest its assets in issuers located in at least three different countries (including the U.S.) and will invest at least 40% of its net assets in foreign securities.

#### Performance Overview

For the 12 months under review, the Fund's Class A shares posted a -27.76% cumulative total return. In comparison, the MSCI ACWI Small Cap Index-NR, which measures performance of small capitalization companies in global developed and emerging markets, posted a -18.73% cumulative total return for the same period.¹ Please note index performance information is provided for reference and we do not attempt to track the index but rather undertake investments on the basis of fundamental research. #### **Economic and Market Overview**

Global developed and emerging market equities, as measured by the MSCI ACWI-NR, posted a -15.88% total return for the 12 months ended August 31, 2022.1 Although global equities benefited earlier in the period from ongoing COVID-19 vaccination programs and some easing of restrictions, the combination of resilient consumer demand and persistent supply-chain disruptions contributed to higher inflation in many countries. This inflationary pressure led many of the world's central banks to adopt less accommodative stances regarding monetary policy in 2022, hindering stocks. New lockdowns imposed by China's government to quell the spread of the Omicron variant of COVID-19 also pressured emerging market stocks, especially in Asia, Russia's invasion of Ukraine also increased investor uncertainty, as international sanctions on Russia disrupted global trade and commodity markets.

In the U.S., after robust growth earlier in the period, gross domestic product (GDP) slightly contracted in the first two quarters of 2022 as high inflation, supply constraints and record trade deficits weighed on economic output. Rising prices precipitated a notable decline in consumer confidence, despite high spending levels, robust job growth and low unemployment. In an effort to control inflation, the U.S. Federal Reserve (Fed) raised the federal funds target rate in March 2022 for the first time since 2018. The Fed raised the federal funds rate again at its subsequent three meetings to end the period at a range of 2.25%–2.50%. Furthermore, the Fed said it would continue to reduce its bond holdings and anticipated additional interest-rate increases at future meetings to curtail inflation.

Economies in the eurozone decelerated to a slightly positive growth rate during the year. The lifting of COVID-related restrictions in some European countries and the summer tourism season strengthened economies. However, the war in Ukraine disrupted supply chains, weakened the economic outlook and contributed to record high inflation across the eurozone, as energy prices soared. Electricity prices hit record highs in Germany and France as coal futures and natural gas prices climbed. Consequently, the European Central Bank raised interest rates in July 2022 for the first time in 11 years to curtail growing inflation. In this environment, European developed market equities, as measured by the MSCI Europe Index-NR, posted a -21.57% total return for the 12 months under review.

Asian developed and emerging market equities, as measured by the MSCI All Country Asia Index-NR, posted a -20.73% total return for the 12-month period.¹ Growth in Japan remained slow, alternating between positive quarterly GDP growth and contraction. China's economy contracted sharply in 2022's second quarter as COVID-related restrictions in many major cities, including Shanghai, weakened consumer demand. Unexpected regulatory changes by China's government, which negatively impacted education- and technology-related businesses, and investor concerns about the solvency of several large property developers in China further pressured stocks in that country.

Global emerging market stocks, as measured by the MSCI Emerging Markets Index-NR, posted a -21.80% total return for the 12 months under review.¹ The index declined for four straight quarters, the longest downturn since 2008, weakened by central bank tightening and the threat of recession. Following Russia's invasion of Ukraine, climbing food and energy prices kindled inflationary pressures and raised concerns over the possibility of government debt defaults in some countries. However, some other countries, particularly in Latin America, as well as South Africa and Saudi Arabia, benefited from rising commodity prices.

#### Investment Strategy

When choosing equity investments for the Fund, we apply a bottom-up, value-oriented, long-term approach, focusing on the market price of a company's securities relative to our evaluation of the company's long-term earnings, asset value and cash flow potential. We also consider the company's price/earnings ratio, profit margins and liquidation value. We may consider selling a security when we believe the security has become overvalued due to either its price appreciation or changes in the company's fundamentals, when we believe that the market capitalization of a security has become

too large, or when we believe another security is a more attractive investment opportunity.

#### Manager's Discussion

In a challenging year for small-cap stocks, which are particularly vulnerable in times of uncertainty, the Fund underperformed its benchmark index. This was primarily due to an overweighting and stock selection in the consumer discretionary sector, stock selection in the industrials sector and lack of exposure to the energy sector.

Sweden-based Dometic Group, which sells equipment to the recreational vehicle (RV), marine and commercial/passenger vehicle market, was the Fund's largest relative detractor. Travel-related stocks such as Dometic were among those most impacted by COVID concerns during the period. Supply

issues have hampered margin improvement, but we believe the situation will eventually normalize. Dometic remains attractive, in our view, with future top-line growth driven by both organic as well as merger-and-acquisition growth. Additionally, we believe a delayed major restructuring program should finally yield full benefits and stronger earnings.

Shares of Sweden-based Thule Group, which focuses on consumer-branded products in the outdoor segment, fell on investor concerns about higher interest rates and their impact on the global economy. Looking at the longer term, the aging, healthier and affluent population is leading to an increased demand for outdoor activities, which has driven strong revenue growth. Additionally, an increase in domestic holidays and "staycations" on the back of COVID is likely supporting demand. The company has proved, in our view, that it can handle rising input costs, supply shortages and elevated demand better than many other manufacturing companies in the Nordic area. Thule's products are of high quality, carry premium prices and are highly rated in open consumer reviews.

Interpump Group, an Italian company specializing in the production of high-pressure water pumps, was impacted by macroeconomic concerns during the period. The company has benefited from a successful merger-and-acquisition strategy. Interpump's ability to implement a large number of bolt-on acquisitions of family-owned companies at limited multiples is due to its soft integration method, which is different from that of larger multinational or private equity groups. Brands are preserved, and the existing management is typically retained and incentivized. We believe this well-established method, in addition to Interpump's focus on well-run companies, reduces integration risk.

In contrast, stock selection in the health care and consumer staples sectors and lack of exposure to the communication services sector contributed to relative performance.

U.S.-based MGP Ingredients, a leading supplier of premium distilled spirits, whiskeys, ryes, bourbons, gins and vodkas, and wheat proteins and starches used in food products, was a major contributor. The company experienced strong growth during the period, and its merger with Lux Row Distillers in 2021 resulted in higher sales of aged whiskey and expanded MGP's branded spirits portfolio. The company's niche brands have historically been purchased more often at bars and restaurants, so we anticipate MGP to benefit as the pandemic recedes and people continue to resume eating and drinking away from home.

M Dias Branco is Brazil's market leader in producing cookies and crackers. The company recovered from recent weakness and finished the period as a top contributor. Looking ahead, we believe the company's market-leading brands and significant competitive advantages it has developed, specifically by vertically integrating and gradually developing distribution across Brazil, can lead to strong share-price performance over our long-term investment horizon.

Acadia Healthcare, a U.S.-based behavioral health care company, has managed pricing/margins well in a difficult environment, and was a strong contributor. Acadia is the market leader in an undersupplied area of health care with what we view as good long-term organic growth potential, where the company has a track record of growth in the U.S. through existing facility expansions, joint ventures with acute care hospitals, and new outpatient clinics for substance abuse. Acadia realized meaningful rate increases from payers in 2022, which led to strong growth in revenue per patient-day that managed to outpace labor cost inflation. Additionally, new management has ramped up the company's growth strategy with a flurry of activity.

Regionally, stock selection in the U.S. was the largest relative detractor for the period. As in other parts of the world, the combination of elevated inflation, tighter monetary policy and chastened consumer confidence weighed on the market. Stock selection in the U.K. and Brazil contributed to relative performance for the year.



#### Total Return Index Comparison for a Hypothetical \$10,000 Investment



# Your Fund's Expenses

As a Fund shareholder, you can incur two types of costs: (1) transaction costs, including sales charges (loads) on Fund purchases and redemptions; and (2) ongoing Fund costs, including management fees, distribution and service (12b-1) fees, and other Fund expenses. All mutual funds have ongoing costs, sometimes referred to as operating expenses. The table below shows ongoing costs of investing in the Fund and can help you understand these costs and compare them with those of other mutual funds. In these columns the Fund's actual return, which includes the effect of Fund expenses, is used to calculate the "Ending Account Value" for each class of shares. You can estimate the expenses you paid during the period by following these steps (of course, your account value and expenses will differ from those in this illustration): Divide your account value by 1,000 (if your account had an 8,600 value, then  $8,600 \div 1,000 = 8.6$ ). Then multiply the result by the number in the row for your class of shares under the headings "Actual" and "Expenses Paid During Period" (if Actual Expenses Paid During Period were 7.50, then  $8.6 \times 7.50 = 64.50$ ). In this illustration, the actual expenses paid this period are 64.50.

#### Hypothetical Example for Comparison with Other Funds

## Notes to Financial Statements

#### 1. Organization and Significant Accounting Policies

Templeton Global Smaller Companies Fund (Fund) is registered under the Investment Company Act of 1940 (1940 Act) as an open-end management investment company and applies the specialized accounting and reporting guidance in U.S. Generally Accepted Accounting Principles (U.S. GAAP). The Fund offers four classes of shares: Class A, Class C, Class R6 and Advisor Class. Class C shares automatically convert to Class A shares on a monthly basis, after they have been held for 8 years. Each class of shares may differ by its initial sales load, contingent deferred sales charges, voting rights on matters affecting a single class, its exchange privilege and fees due to differing arrangements for distribution and transfer agent fees.

The following summarizes the Fund's significant accounting policies.

#### a. Financial Instrument Valuation

The Fund's investments in financial instruments are carried at fair value daily. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. The Fund calculates the net asset value (NAV) per share each business day as of 4 p.m. Eastern time or the regularly scheduled close of the New York Stock Exchange (NYSE), whichever is earlier. Under compliance policies and procedures approved by the Fund's Board of Trustees (the Board), the Fund's administrator has responsibility for oversight of valuation, including leading the cross-functional Valuation Committee (VC). The Fund may utilize independent pricing services, quotations from securities and financial instrument dealers, and other market sources to determine fair value.

Equity securities listed on an exchange or on the NASDAQ National Market System are valued at the last quoted sale price or the official closing price of the day, respectively. Foreign equity securities are valued as of the close of trading on the foreign stock exchange on which the security is primarily traded, or as of 4 p.m. Eastern time. The value is then converted into its U.S. dollar equivalent at the foreign exchange rate in effect at 4 p.m. Eastern time on the day that the value of the security is determined. Over-the-counter (OTC) securities are valued within the range of the most recent quoted bid and ask prices. Securities that trade in multiple markets or on multiple exchanges are valued

according to the broadest and most representative market. Certain equity securities are valued based upon fundamental characteristics or relationships to similar securities.

Debt securities generally trade in the OTC market rather than on a securities exchange. The Fund's pricing services use multiple valuation techniques to determine fair value. In instances where sufficient market activity exists, the pricing services may utilize a market-based approach through which quotes from market makers are used to determine fair value. In instances where sufficient market activity may not exist or is limited, the pricing services also utilize proprietary valuation models which may consider market characteristics such as benchmark yield curves, credit spreads, estimated default rates, anticipated market interest rate volatility, coupon rates, anticipated timing of principal repayments, underlying collateral, and other unique security features in order to estimate the relevant cash flows, which are then discounted to calculate the fair value.

Investments in open-end mutual funds are valued at the closing NAV.

The Fund has procedures to determine the fair value of financial instruments for which market prices are not reliable or readily available. Under these procedures, the Fund primarily employs a market-based approach which may use related or comparable assets or liabilities, recent transactions, market multiples, book values, and other relevant information for the investment to determine the fair value of the investment. An income-based valuation approach may also be used in which the anticipated future cash flows of the investment are discounted to calculate fair value. Discounts may also be applied due to the nature or duration of any restrictions on the disposition of the investments. Due to the inherent uncertainty of valuations of such investments, the fair values may differ significantly from the values that would have been used had an active market existed.

Trading in securities on foreign securities stock exchanges and OTC markets may be completed before 4 p.m. Eastern time. In addition, trading in certain foreign markets may not take place on every Fund's business day. Events can occur between the time at which trading in a foreign security is completed and 4 p.m. Eastern time that might call into question the reliability of the value of a portfolio security held by the Fund. As a result, differences may arise between the value of the Fund's portfolio securities as determined at the foreign market close and the latest indications of value at

4 p.m. Eastern time. In order to minimize the potential for these differences, an independent pricing service may be used to adjust the value of the Fund's portfolio securities to the latest indications of fair value at 4 p.m. Eastern time. At August 31, 2022, certain securities may have been fair valued using these procedures, in which case the securities were categorized as Level 2 inputs within the fair value hierarchy (referred to as "market level fair value"). See the Fair Value Measurements note for more information.

When the last day of the reporting period is a non-business day, certain foreign markets may be open on those days that the Fund's NAV is not calculated, which could result in differences between the value of the Fund's portfolio securities on the last business day and the last calendar day of the reporting period. Any security valuation changes due to an open foreign market are adjusted and reflected by the Fund for financial reporting purposes.

#### b. Foreign Currency Translation

Portfolio securities and other assets and liabilities denominated in foreign currencies are translated into U.S. dollars based on the exchange rate of such currencies against U.S. dollars on the date of valuation. The Fund may enter into foreign currency exchange contracts to facilitate transactions denominated in a foreign currency. Purchases and sales of securities, income and expense items denominated in foreign currencies are translated into U.S. dollars at the exchange rate in effect on the transaction date. Portfolio securities and assets and liabilities denominated in foreign currencies contain risks that those currencies will decline in value relative to the U.S. dollar. Occasionally, events may impact the availability or reliability of foreign exchange rates used to convert the U.S. dollar equivalent value. If such an event occurs, the foreign exchange rate will be valued at fair value using procedures established and approved by the Board.

The Fund does not separately report the effect of changes in foreign exchange rates from changes in market prices on securities held. Such changes are included in net realized and unrealized gain or loss from investments in the Statement of Operations.

Realized foreign exchange gains or losses arise from sales of foreign currencies, currency gains or losses realized between the trade and settlement dates on securities transactions and the difference between the recorded amounts of dividends, interest, and foreign withholding taxes and the U.S. dollar equivalent of the amounts actually received or paid. Net unrealized foreign exchange gains and losses arise from changes in foreign exchange rates on foreign denominated assets and liabilities other than investments in securities held at the end of the reporting period.

#### c. Securities Lending

The Fund participates in an agency based securities lending program to earn additional income. The Fund receives collateral in the form of cash and/or U.S. Government and Agency securities against the loaned securities in an amount equal to at least 102% of the fair value of the loaned securities. Collateral is maintained over the life of the loan in an amount not less than 100% of the fair value of loaned securities, as determined at the close of Fund business each day; any additional collateral required due to changes in security values is delivered to the Fund on the next business day. Any cash collateral received is deposited into a joint cash account with other funds and is used to invest in a money market fund managed by Franklin Advisers, Inc., an affiliate of the Fund. Additionally, at August 31, 2022, the Fund held \$69,238,541 in U.S. Government and Agency securities as collateral. These securities are held as collateral in segregated accounts with the Fund's custodian. The Fund cannot repledge or resell these securities held as collateral. As such, the non-cash collateral is excluded from the Statement of Assets and Liabilities. The Fund may receive income from the investment of cash collateral, in addition to lending fees and rebates paid by the borrower. Income from securities loaned, net of fees paid to the securities lending agent and/ or third-party vendor, is reported separately in the Statement of Operations. The Fund bears the market risk with respect to any cash collateral investment, securities loaned, and the risk that the agent may default on its obligations to the Fund. If the borrower defaults on its obligation to return the securities loaned, the Fund has the right to repurchase the securities in the open market using the collateral received. The securities lending agent has agreed to indemnify the Fund in the event of default by a third party borrower.

## 1. Organization and Significant Accounting Policies (continued)

#### d. Income and Deferred Taxes

It is the Fund's policy to qualify as a regulated investment company under the Internal Revenue Code. The Fund intends to distribute to shareholders substantially all of its taxable income and net realized gains to relieve it from federal income and excise taxes. As a result, no provision for U.S. federal income taxes is required.

The Fund may be subject to foreign taxation related to income received, capital gains on the sale of securities and certain foreign currency transactions in the foreign jurisdictions in which it invests. Foreign taxes, if any, are recorded based on the tax regulations and rates that exist in the foreign markets in which the Fund invests. When a capital gain tax is determined to apply, the Fund records an estimated deferred tax liability in an amount that would be payable if the securities were disposed of on the valuation date.

As a result of several court cases, in certain countries across the European Union, the Fund filed additional tax reclaims for previously withheld taxes on dividends earned in those countries (EU reclaims). Income recognized, if any, for EU reclaims is reflected as other income in the Statement of Operations and any related receivable, if any, is reflected as European Union tax reclaims in the Statement of Assets and Liabilities. Any fees associated with these filings are reflected in other expenses in the Statement of Operations. When uncertainty exists as to the ultimate resolution of these proceedings, the likelihood of receipt of these EU reclaims, and the potential timing of payment, no amounts are reflected in the financial statements. For U.S. income tax purposes, EU reclaims received by the Fund, if any, reduce the amount of foreign taxes Fund shareholders can use as tax deductions or credits on their income tax returns.

The Fund may recognize an income tax liability related to its uncertain tax positions under U.S. GAAP when the uncertain tax position has a less than 50% probability that it will be sustained upon examination by the tax authorities based on its technical merits. As of August 31, 2022, the Fund has determined that no tax liability is required in its financial statements related to uncertain tax positions for any open tax years (or expected to be taken in future tax years). Open

tax years are those that remain subject to examination and are based on the statute of limitations in each jurisdiction in which the Fund invests.

## e. Security Transactions, Investment Income, Expenses and Distributions

Security transactions are accounted for on trade date. Realized gains and losses on security transactions are determined on a specific identification basis. Interest income and estimated expenses are accrued daily. Amortization of premium and accretion of discount on debt securities are included in interest income. Dividend income is recorded on the ex-dividend date except for certain dividends from securities where the dividend rate is not available. In such cases, the dividend is recorded as soon as the information is received by the Fund. Distributions to shareholders are recorded on the ex-dividend date. Distributable earnings are determined according to income tax regulations (tax basis) and may differ from earnings recorded in accordance with U.S. GAAP. These differences may be permanent or temporary. Permanent differences are reclassified among capital accounts to reflect their tax character. These reclassifications have no impact on net assets or the results of operations. Temporary differences are not reclassified, as they may reverse in subsequent periods.

Realized and unrealized gains and losses and net investment income, excluding class specific expenses, are allocated daily to each class of shares based upon the relative proportion of net assets of each class. Differences in per share distributions by class are generally due to differences in class specific expenses.

#### f. Accounting Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

#### g. Guarantees and Indemnifications

Under the Fund's organizational documents, its officers and trustees are indemnified by the Fund against certain liabilities arising out of the performance of their duties to the Fund. Additionally, in the normal course of business, the Fund enters into contracts with service providers that contain general indemnification clauses. The Fund's maximum

exposure under these arrangements is unknown as this would involve future claims that may be made against the Fund that have not yet occurred. Currently, the Fund expects the risk of loss to be remote.

The Fund pays an investment management fee, calculated daily and paid monthly, to TIC based on the average daily net assets of the Fund as follows:

For the year ended August 31, 2022, the gross effective investment management fee rate was 0.870% of the Fund's average daily net assets.

Under a subadvisory agreement, FTIC, an affiliate of TIC, provides subadvisory services to the Fund. The subadvisory fee is paid by TIC based on the Fund's average daily net assets, and is not an additional expense of the Fund.

#### b. Administrative Fees

Under an agreement with TIC, FT Services provides administrative services to the Fund. The fee is paid by TIC based on the Fund's average daily net assets, and is not an additional expense of the Fund.

#### c. Distribution Fees

The Board has adopted distribution plans for each share class, with the exception of Class R6 and Advisor Class shares, pursuant to Rule 12b-1 under the 1940 Act. Under the Fund's Class A reimbursement distribution plan, the Fund reimburses Distributors for costs incurred in connection with the servicing, sale and distribution of the Fund's shares up to the maximum annual plan rate. Under the Class A reimbursement distribution plan, costs exceeding the maximum for the current plan year cannot be reimbursed in subsequent periods. In addition, under the Fund's Class C compensation distribution plan, the Fund pays Distributors for costs incurred in connection with the servicing, sale and distribution of the Fund's shares up to the maximum annual plan rate. The plan year, for purposes of monitoring compliance with the maximum annual plan rates, is February 1 through January 31.

The maximum annual plan rates, based on the average daily net assets, for each class, are as follows:

#### d. Sales Charges/Underwriting Agreements

Front-end sales charges and contingent deferred sales charges (CDSC) do not represent expenses of the Fund. These charges are deducted from the proceeds of sales of Fund shares prior to investment or from redemption proceeds prior to remittance, as applicable. Distributors has advised the Fund of the following commission transactions related to the sales and redemptions of the Fund's shares for the year:

#### e. Transfer Agent Fees

Each class of shares pays transfer agent fees to Investor Services for its performance of shareholder servicing obligations. The fees are based on an annualized asset based fee of 0.02% plus a transaction based fee. In addition, each class reimburses Investor Services for out of pocket expenses incurred and, except for Class R6, reimburses shareholder servicing fees paid to third parties. These fees are allocated daily based upon their relative proportion of such classes' aggregate net assets. Class R6 pays Investor Services transfer agent fees specific to that class.

For the year ended August 31, 2022, the Fund paid transfer agent fees of \$1,562,320, of which \$489,452 was retained by Investor Services

#### f. Investments in Affiliated Management Investment Companies

The Fund invests in one or more affiliated management investment companies. As defined in the 1940 Act, an investment is deemed to be a "Controlled Affiliate" of a fund when a fund owns, either directly or indirectly, 25% or more of the affiliated fund's outstanding shares or has the power to exercise control over management or policies of such fund. The Fund does not invest for purposes of exercising a controlling influence over the management or policies. Management fees paid by the Fund are waived on assets invested in the affiliated management investment companies, as noted in the Statement of Operations, in an amount not to exceed the management and administrative fees paid directly or indirectly by each affiliate. Differences between income and/or capital gains as determined on a book basis and a tax basis are primarily due to differing treatments of EU reclaims, passive foreign investment company shares, pass-through entity income, corporate actions and wash sales.

The Fund utilized a tax accounting practice to treat a portion of the proceeds from capital shares redeemed as a distribution from net investment income.

#### 5. Investment Transactions

Purchases and sales of investments (excluding short term securities) for the year ended August 31, 2022, aggregated \$153,004,964 and \$215,311,881, respectively.

At August 31, 2022, in connection with securities lending transactions, the Fund loaned equity investments and received \$27,614 of cash collateral. The gross amount of recognized liability for such transactions is included in payable upon return of securities loaned in the Statement of Assets and Liabilities. The agreements can be terminated at any time.

#### 6. Concentration of Risk

Investing in foreign securities may include certain risks and considerations not typically associated with investing in U.S. securities, such as fluctuating currency values and changing local, regional and global economic, political and social conditions, which may result in greater market volatility. Political and financial uncertainty in many foreign regions may increase market volatility and the economic risk of investing in foreign securities. In addition, certain foreign securities may not be as liquid as U.S. securities.

#### 7. Geopolitical Risk

On February 24, 2022, Russia engaged in military actions in the sovereign territory of Ukraine. The current political and financial uncertainty surrounding Russia and Ukraine may increase market volatility and the economic risk of investing in securities in these countries and may also cause uncertainty for the global economy and broader financial markets. The ultimate fallout and long-term impact from these events are not known. The Fund will continue to assess the impact on valuations and liquidity and will take any potential actions needed in accordance with procedures approved by the Board.

#### 8. Novel Coronavirus Pandemic

The global outbreak of the novel coronavirus disease, known as COVID-19, has caused adverse effects on many companies, sectors, nations, regions and the markets in general, and may continue for an unpredictable duration. The effects of this pandemic may materially impact the value and performance of the Fund, its ability to buy and sell fund investments at appropriate valuations and its ability to achieve its investment objectives.

#### 9. Restricted Securities

The Fund invests in securities that are restricted under the Securities Act of 1933 (1933 Act). Restricted securities are often purchased in private placement transactions, and cannot be sold without prior registration unless the sale is pursuant to an exemption under the 1933 Act. Disposal of these securities may require greater effort and expense, and prompt sale at an acceptable price may be difficult. The Fund may have registration rights for restricted securities. The issuer generally incurs all registration costs.

#### 10. Credit Facility

The Fund, together with other U.S. registered and foreign investment funds (collectively, Borrowers), managed by Franklin Templeton, are borrowers in a joint syndicated senior unsecured credit facility totaling \$2.675 billion (Global Credit Facility) which matures on February 3, 2023. This Global Credit Facility provides a source of funds to the Borrowers for temporary and emergency purposes, including the ability to meet future unanticipated or unusually large redemption requests.

Under the terms of the Global Credit Facility, the Fund shall, in addition to interest charged on any borrowings made by the Fund and other costs incurred by the Fund, pay its share of fees and expenses incurred in connection with the implementation and maintenance of the Global Credit Facility, based upon its relative share of the aggregate net assets of all of the Borrowers, including an annual commitment fee of 0.15% based upon the unused portion of the Global Credit Facility. These fees are reflected in other expenses in the Statement of Operations. During the year ended August 31, 2022, the Fund did not use the Global Credit Facility.

#### 11. Fair Value Measurements

The Fund follows a fair value hierarchy that distinguishes between market data obtained from independent sources (observable inputs) and the Fund's own market assumptions (unobservable inputs). These inputs are used in determining the value of the Fund's financial instruments and are summarized in the following fair value hierarchy:

## Liquidity Risk Management Program

Each Fund has adopted and implemented a written Liquidity Risk Management Program (the "LRMP") as required by Rule 22e-4 under the Investment Company Act of 1940 (the "Liquidity Rule"). The LRMP for the Franklin Templeton and Legg Mason Funds is designed to assess and manage each Fund's liquidity risk, which is defined as the risk that the Fund could not meet requests to redeem shares issued by the Fund without significant dilution of remaining investors' interests in the Fund. In accordance with the Liquidity Rule, the LRMP includes policies and procedures that provide for: (1) assessment, management, and review (no less frequently than annually) of each Fund's liquidity risk; (2) classification of each Fund's portfolio holdings into one of four liquidity categories (Highly Liquid, Moderately Liquid, Less Liquid, and Illiquid); (3) for Funds that do not primarily hold assets that are Highly Liquid, establishing and maintaining a minimum percentage of the Fund's net assets in Highly Liquid investments (called a "Highly Liquid Investment Minimum" or "HLIM"); and (4) prohibiting the Fund's acquisition of Illiquid investments that would result in the Fund holding more than 15% of its net assets in Illiquid assets. The LRMP also requires reporting to the Securities and Exchange Commission ("SEC") (on a non-public basis) and to the Board if the Fund's holdings of Illiquid assets exceed 15% of the Fund's net assets. Funds with HLIMs must have procedures for addressing HLIM shortfalls, including reporting to the Board and, with respect to HLIM shortfalls lasting more than seven consecutive calendar days, reporting to the SEC (on a non-public basis).

The Director of Liquidity Risk within the Investment Risk Management Group (the "IRMG") is the appointed Administrator of the LRMP. The IRMG maintains the Investment Liquidity Committee (the "ILC") to provide oversight and administration of policies and procedures governing liquidity risk management for Franklin Templeton and Legg Mason products and portfolios. The ILC includes representatives from Franklin Templeton's Risk, Trading, Global Compliance, Legal, Investment Compliance, Investment Operations, Valuation Committee, Product Management and Global Product Strategy.

In assessing and managing each Fund's liquidity risk, the ILC considers, as relevant, a variety of factors, including the Fund's investment strategy and the liquidity of its portfolio investments during both normal and reasonably foreseeable stressed conditions; its short and long-term cash flow projections; and its cash holdings and access to

other funding sources including the Funds' interfund lending facility and line of credit. Classification of the Fund's portfolio holdings in the four liquidity categories is based on the number of days it is reasonably expected to take to convert the investment to cash (for Highly Liquid and Moderately Liquid holdings) or sell or dispose of the investment (for Less Liquid and Illiquid investments), in current market conditions without significantly changing the investment's market value.

Each Fund primarily holds liquid assets that are defined under the Liquidity Rule as "Highly Liquid Investments," and therefore is not required to establish an HLIM. Highly Liquid Investments are defined as cash and any investment reasonably expected to be convertible to cash in current market conditions in three business days or less without the conversion to cash significantly changing the market value of the investment.

At meetings of the Funds' Board of Trustees held in May 2022, the Program Administrator provided a written report to the Board addressing the adequacy and effectiveness of the program for the year ended December 31, 2021. The Program Administrator report concluded that (i.) the LRMP, as adopted and implemented, remains reasonably designed to assess and manage each Fund's liquidity risk; (ii.) the LRMP, including the Highly Liquid Investment Minimum ("HLIM") where applicable, was implemented and operated effectively to achieve the goal of assessing and managing each Fund's liquidity risk; and (iii.) each Fund was able to meet requests for redemption without significant dilution of remaining investors' interests in the Fund.

## Proxy Voting Policies and Procedures

The Fund's investment manager has established Proxy Voting Policies and Procedures (Policies) that the Fund uses to determine how to vote proxies relating to portfolio securities. Shareholders may view the Fund's complete Policies online at franklintempleton.com.
